### **Working Groups**

In this second activity, the group was asked to discuss projects that would assist in addressing some of the weaknesses or needs in the community. At the end of the identification of meaningful projects, the group was given three stickers and asked to vote for specific projects. They were allowed to place their stickers as they chose with one sticker by three various projects or all their stickers by a particular project.

### **Economy**

#### **VA Complex**

County continues to work toward a solution on whether to accept ownership of the VA Complex. This could potentially impact businesses and groups currently located there. Additionally, location of current VA services could be impacted in near future.

#### **Event/Convention Center**

Work toward establishing an Event/Convention Center at the fairgrounds capable of holding an event for approximately 1000 persons. This would supplement existing tourism efforts as well as create a whole new avenue of events Miles City could host.

### **MCYHA** Improvements

Support the necessary improvements to the Agri Sports Complex so additional hockey events can be hosted during the winter months as this creates additional revenue for Miles City businesses in an off season and further diversifies the overall economy in Miles City by strengthening tourism revenues.

#### Westend Development

Continue to work with the City of Miles City toward industrial development on the west end of Miles City. Also support tourism efforts and beautification efforts to make that entrance to Miles City more inviting.

### TIF/Opportunity Zone

Explore opportunities to utilize TIF or Opportunity Zone more effectively.

#### GIS Business Recruitment Tools

Continue to develop GIS tools utilizing ArcGIS within the County. Past focus has been Next Gen 911 and Emergency Services. Expand services to include a business recruitment tool for Miles City to market and make available information and statistics about Custer County and Miles City.

### Housing

### **MCC** Housing Needs

Establish additional housing for MCC as their enrollment is expanding. Needs for married student housing as well.

#### Affordable Housing

Encourage the development of workforce housing in an effort to expand affordable housing options for new employees.

### **Quality of Life**

### Marketing of Miles City (Tourism, Entrepreneurs, Businesses, Potential Young Residents)

Support efforts to market Miles City to potential businesses, entrepreneurs and potential young residents. Continue to market tourism. Work toward improving overall content management of various key organizations such as City, County, Economic Development. Choose one marketing theme and promote Miles City in a united effort.

### Centra Expansion

Expand the Centra to create more availability for various activities to the public and make more availability for sports at MCC. This could serve for additional youth type programs and make more times available for public use.

### **Public Transportation Program**

Continue to expand and improve public transportation program by offering transportation to other areas for senior citizens and others in need of public transportation.

### **Proposed Quality of Life Projects (Those receiving votes)**

Marketing of Miles City – 5 Votes

### **Services and Infrastructure**

### **CCMC Flood Control Project**

Miles City continues to struggle with matters associated with the existing levee which is not certified, and the floodplain. Section 205 funding has been obtained and a steering committee with sub committees continues to pursue this project with the first phase being a feasibility study to be conducted by the Corp of Engineers.

### **Airport Improvements**

Continue to support efforts to improve the airport infrastructure.

### City CIP and Growth Policy

Capital Improvement Plans (CIP) are becoming necessary to point competitively for infrastructure type grants. Assist City in obtaining funding to complete a CIP. Growth Policy is now 5 years old as well and needs to be updated

#### **County Growth Policy**

Assist County in obtaining funding to complete a Growth Policy as current Growth Policy is now 5 years old and needs to be updated.

### **School Building Upgrades**

All school buildings including the college are in need of continual maintenance and capital improvement projects. Support necessary funding to continue to maintain infrastructure.

### City Fire Building/Police Building

The fire department building is facing condemnation of a portion of it and funding to replace it is necessary. The police department is also looking to find a permanent location.

#### **County Fire Building**

Support efforts of the County to expand and improve the current Custer County Fire building facility.

### Tussler Bridge

Tussler bridge is in need of significant repair. Commissioners are seeking funding to accomplish this project.
